

# PRIVACY POLICY LEGACY DANCE EVENTS

We consider the protection of your privacy extremely important. We want to give you as much information as possible about what happens to your personal data. In this policy you will find information about what data we collect, why we do it, how we protect it and how you can exercise your privacy rights.

## 1. Who processes your data?

'Legacy Dance Events' with registered office in Hasselt, Salamanderstraat 3 bus 0.03 and registered with the KBO under number BE07 1758 5016 is responsible for the processing of your personal data as collected on our website or via our services, hereinafter "our company" or "we".

## 2. What data do we collect?

We collect the information and data that you give us yourself when you use the registration form on our website or via email, including:

- salutation;
- Name;
- First name;
- E-mail address;
- Date of birth + age;
- Telephone/Gsm number;

We also collect data resulting from collaborations (sponsorship, ...).

### More information:

- When we conclude a contract with you as a customer, supplier and/or sponsor, we collect data such as surname, first name, e-mail address, postal address, telephone number, VAT number, account number and position within the company.
- When you participate in our courses or competitions, we collect all the data you provide when registering. This data is only shared with the organizers and the teachers or judges.

## 3. How and why do we use your data?

We process personal data for various purposes, whereby we only process the data that is necessary to achieve the intended purpose on the basis of the criteria provided by law. Your data is mainly used for the following purposes:

- process your registration and accept payment;
- keep you informed of all information related to our events;
- provide you with products/services and improve that delivery;
- offer you benefits;
- communicate with you and inform you better about our events, internships, activities,...
- manage our activities;
- run our marketing and advertising campaigns;
- because you want us to store your data, for example to keep you informed
- love future editions organized by Legacy Dance Events;

- for customer and supplier management (including invoicing and solvency monitoring) to prevent fraud.

#### More information:

To process your personal data, we always lean on:

- The consent you give us by participating in our events, or by choosing to contact us via email. the contact form. In that case, you always have the option to withdraw your consent with effect for the future.

#### **4. Minors**

We care about protecting the privacy of minors and encourage parents to be actively involved in their children's online activities.

#### **5. How and who is that information shared with?**

We do not share your data with third parties. Furthermore, we will not provide your data to other third parties without your prior consent, unless we have a legitimate interest or are obliged to do so on the basis of a legal provision or a court decision.

#### More information

In certain cases, the data may be communicated to third parties who provide services to us or who provide services in our name and on our behalf. This may involve intermediaries who arrange access control and/or registrations. Using such service providers and sharing your information helps us to provide and improve our services.

In addition, we are obliged to communicate your personal data when this is required by law or by a court decision.

We will only pass on your personal data if your interests or your fundamental rights and freedoms do not prevail and you will always be transparently informed about this (except in the case of legal exceptions).

If we would pass on personal data to third parties in other situations, this will be done with your permission where required by law.

In any case, we undertake to ensure the confidentiality of your data, in particular by concluding appropriate contracts with third parties.

#### **6. How can you manage/access your data and delete it?**

You have the right to correct your data or have it corrected, the right to delete your data, the right to object to the processing of your data or profiling, the right to limit the processing of your data and the right on the portability of your data.

#### More information

In accordance with applicable regulations, you have the right to:

- ask for the data to be corrected or, if necessary, deleted, in particular when such data is no longer necessary in view of the purposes for which it was collected/processed or when you withdraw your consent;
- object to the processing of the data concerning you in certain specific cases, including processing for direct marketing purposes; in that case we will no longer process your data, unless for legitimate and compelling reasons that outweigh your interests and rights and freedoms or if the processing is related to the establishment, exercise or defense of legal claims;

- oppose automated individual decision-making, including profiling;
- ask for the processing to be restricted, in particular when you verify the correctness of the contest data, for a period that allows us to verify the accuracy of that data.

You can exercise those rights by sending a written request, or by email to [legacydancecompetition@outlook.com](mailto:legacydancecompetition@outlook.com). We will respond to your request as soon as possible, and in any event within one month of receipt of your request. Depending on the complexity of the requests and the number of requests, that period may be extended by a further two months. We will inform you in that case.

We will grant you all rights to which you are entitled under applicable law. In this context, we refer in particular to the exceptions to the aforementioned rights that apply to processing for journalistic purposes and for academic, artistic or literary forms of expression. Complaints in case of violation of the applicable Belgian rules regarding the protection of personal data can be addressed to the Data Protection Authority at the address [contact\(at\)apd-gba.be](mailto:contact(at)apd-gba.be).

## **7. How long do we keep your information?**

Your data will never be kept longer than necessary. When we no longer need to use your information, and there is no need for us to keep it to comply with legal or regulatory obligations, we delete the information from our systems.

We take administrative measures to fully guarantee the protection of your data against any destruction, loss or alteration.
